- The maximum eligible funding amount for your project
- A RetrofitHH file reference number for tracking your application
- Information for contacting an Enbridge-approved Registered Energy Advisor to arrange for a Pre-Retrofit Home Energy Assessment, the cost of which is not eligible for re-imbursement under this Program
