The program starts in April each year and runs to the following March.

The Town of Halton Hills will supply and install the panels. The advertiser is responsible to have the artwork completed to the established guidelines and to acquire a company to manufacture the ad on the supplied panel. Please note this comes at an extra cost to the advertiser in order to have the artwork put on the panels. **The Town must approve all artwork in advance. Current advertisers who are looking to update their artwork will need to have ads approved prior to manufacturing new panels and will pay a minimal fee of \$84.75 to cover costs to remove sign and install new sign.**

Advertisers can join the program throughout the season and will be provided a pro-rated fee. This will be allowed at a 6 month maximum ending September 30, 2021. Advertisers who wish to join the program past October 1st will be required to join for a one year plus term which will be dictated on when the advertiser joins the program.
