

Community Event Signs on Road Allowance

Portable signs advertising the community events may be temporarily installed on road allowance. The signs will require a sign permit and will be subject to the provisions of Sign By-law 2003-0065, as amended.

The portable signs should be removed within 48 hours after the event. If not removed within this timeframe, you will be subject to a sign removal fee.

Terms and Conditions

When submitting the Community Event Signs on Road Allowance form for approval, please ensure the following:

- Proposed number of Event Signs within the municipal boundary of the Town of Halton Hills shall not exceed 30 signs.
- The proposed Event Signs shall not exceed 6 square feet (or 24" x 36") per Sign Face Area.
- All Event Signs on Regional or Ministry of Transportation roads should be approved by the corresponding authorities:
 - Halton Region
 - Trafalgar Road (Regional Road 3)
 - Steeles Avenue (Regional Road 8)
 - Ninth Line (Regional Road 13) south of 10 Side Road
 - 10 Side Road east of Trafalgar
 - Regional Road 25
 - Peel Region
 - Winston Churchill Boulevard (Regional Road 19)
 - Ministry of Transportation
 - Guelph Street (Highway 7) east of Hall Road, west of Caseley Drive
 - Highway 7 outside Connecting Link (C.L.) yellow markers
- The maximum duration that signs can be erected on Town road allowance shall not exceed 3 weeks.
- Include a map clearly illustrating how the Event Sign(s) will appear on the road allowance.
- Include a picture of the Event Sign.

Upon installation, please ensure that the following criteria are met:

- No Event Sign shall be installed within 30 metres of any intersection.
- The proposed Event Sign locations shall not obstruct vehicle or pedestrian sightlines.
- The Event Signs shall not compete with any existing traffic signs.
- Event Signs shall be kept at least 2 metres away from the sidewalk or the curb.
- No Event Sign shall be placed on a median.
