RETAIN YOUR TAX BILL

Property taxes may be claimed when filing income tax. If you require confirmation of payment in full; tax bills may be stamped with payment receipt at the Town Hall service counter.

OWNERSHIP CHANGES

If you've recently moved, ownership changes will be processed once we receive notification from the Municipal Property Assessment Corporation (MPAC). This typically takes 3-5 weeks from the closing date. Once an ownership change is processed, we will mail the new homeowners a confirmation letter, stating the new roll number, current balance and upcoming tax due dates.



SUPPLEMENTARY TAX BILLINGS

If your property is under construction, being renovated or is a newly constructed building, you may not be fully assessed. Once the Town receives the necessary assessment information from MPAC (Municipal Property Assessment Corporation) you will be issued a supplementary tax bill.



PROPERTY ASSESSMENTS

The Municipal Property Assessment Corporation (MPAC) is responsible for determining the assessment class(es) and value(s) for each property in Ontario.

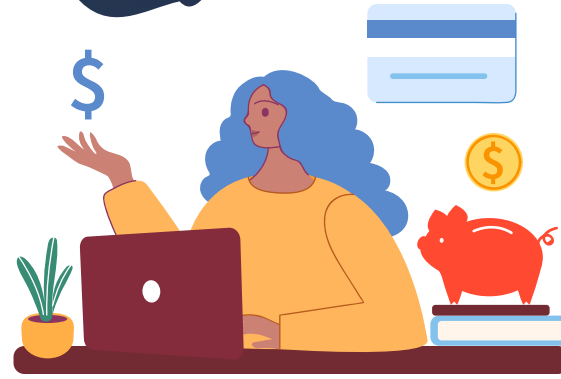

TAX PAYMENT OPTIONS



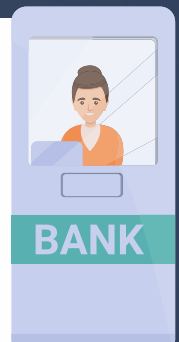

FINANCIAL INSTITUTIONS

Payments can be made at any financial institution or through internet or phone banking. Pay your taxes from your bank account by adding us as a payee:

- **Payee name: Halton Hills Taxes (Town)**
- **Account number: Your 19-digit roll number**

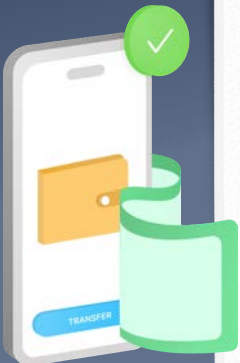
Your payment is not considered made until the money is credited to the Town's account. Please make payment **three** business days in advance of the due date to ensure payment reaches the Town prior to or on the due date.

PRE-AUTHORIZED PAYMENT PLAN

For your convenience, the Town of Halton Hills can make pre-authorized automatic withdrawals from your bank account for tax payments. Please note that you may only enroll in the Pre-authorized Payment Plan if all taxes have been paid up-to-date.

MAIL YOUR CHEQUE

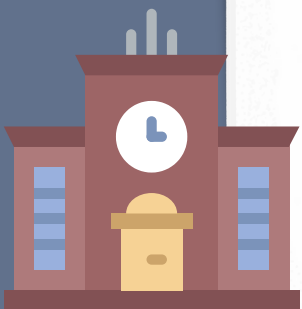

IN-PERSON

Payments can be made by cash, debit or cheque at Town Hall, 1 Halton Hills Drive, Monday to Friday 8:30 a.m. to 4:30 p.m.

AFTER HOURS DROP BOX

A secure drop box is located to the right of the front door of the Town Hall office, located at 1 Halton Hills Drive. Payments must be received by the Town by end of business on the due date to avoid penalty.
