**RE: 2024 Seniors Property Tax Grant Application**

You will find the Seniors Property Tax Grant application form for the year 2024 on the back of this letter. An application must be submitted each year with one of the required proof of income documents listed below to qualify for the current year's grant program. The deadline for the rebate approval is **October 1, 2024**; your tax account must be current and in good standing to receive the grant.

**If your application is approved, you will receive a \$500.00 grant that will be applied as a rebate to your property tax account.** The rebate will reflect on your tax bill as a credit applied to the Final installments. If your property taxes are paid in full for the year, the rebate will be applied to your tax account as a credit towards the following tax year; this will reflect on your 2025 Interim tax bill.

Please complete the 2024 Seniors Property Tax Grant application form on the back of this page and return to our office by the deadline of October 1, 2024 with a copy of either:

- **Statement of Old Age Security T4A(OAS) for the prior year**

OR

- **Guaranteed Income Supplement Entitlement letter confirming receipt of supplement**
